## Question 1

### 3 points

One point is earned for correctly defining the concept of regime change.

Acceptable definitions may include:

- A regime change is when there is a complete transformation of the political system, such as a transition from authoritarianism to democracy.
- A regime change is a change to the constitution or a change to the fundamental laws structuring the government in a way that transforms the political system.

One point is earned for correctly identifying a country studied in the AP Comparative Government and Politics course that has experienced a regime change since 1990.

Acceptable identifications include:

- Mexico
- Nigeria
- Russia

One point is earned for a correct explanation of how a regime change is different from a change in government.

Acceptable explanations may include:

Regime change involves the transformation of the type of political system, whereas governmental change involves the replacement of individual leaders or political parties.

A score of zero (0) is earned for an attempted or off-task answer that earns no points.

A score of (—) is earned for a blank.

# AP® COMPARATIVE GOVERNMENT AND POLITICS 2019 SCORING COMMENTARY

## **Question 1**

**Note:** Student samples are quoted verbatim and may contain spelling and grammatical errors.

#### **Overview**

The intent of this question was to assess students' understanding of regime change and the difference between regime change and a change in government. The skills tested were descriptive and explanatory. Students had three specific tasks: to define the concept of regime change, to identify a country studied within the AP Comparative Government and Politics course that has experienced a regime change since 1990, and to explain how a change in regime is different from a change in government.

Sample: 1A Score: 3

The response earned 1 point for correctly defining the concept of regime change as "when the way in which a government is run changes (the system of government). For example, a regime change would be a transition from authoritarian to democratic presidential rule." Additional acceptable responses include that a regime change is a complete transformation of the political system, a change to the constitution, or a change to the fundamental laws structuring the government in a way that transforms the political system.

The response earned 1 point for correctly identifying Nigeria as a country that has experienced a regime change since 1990. Additional acceptable responses include Mexico and Russia.

The response earned 1 point for correctly explaining that a change in regime is different from a change in government "because the system itself is changing, not just the person or party in power."

Sample: 1B Score: 2

The response did not earn a point for defining the concept of regime change. The definition of regime change as "when the type of government within a state changes" does not specify that regime change is a complete transformation of the political system.

The response earned 1 point for correctly identifying Russia as a country that has experienced a regime change since 1990. Additional acceptable responses include Mexico and Nigeria.

The response earned 1 point for correctly explaining how a change in regime is different from a change in government because a "change in regime is changing the political institutions while a change in government is changing the leader or ruler of a state."

## Question 1 (continued)

Sample: 1C Score: 1

The response did not earn a point for defining the concept of regime change. The definition of regime change as "a change in the way a political system interacts with its population, markets, and the world" does not make clear that the system itself is completely transformed.

The response earned 1 point for correctly identifying Nigeria as a country that has experienced a regime change since 1990. Additional acceptable responses include Mexico and Russia.

The response did not earn a point for explaining how a change in regime is different from a change in government. The statement that "regime change is different to a change in government because a change in government is only a change in administration" does not adequately explain that a regime change is a more sweeping, systemic change.
